### **PUBLICATION OF CONFERENCE MATERIALS**

Abstracts of participants' reports will be published prior to the conference,. Conference participants will receive a certificate of participation. A collection of abstracts (electronic version) will be sent to those who participated in the conference remotely.

### **ORGANIZATIONAL FEE**

The organizational fee for reimbursement of the costs of the conference and publication of abstracts is:

- printed version + certificate - **200 UAH**;
- electronic version of the collection of abstracts + certificate - **120 UAH**;

- Foreign conference participants receive an electronic version of the collection of abstracts - free of charge.

### **RULES FOR SUBMISSION AND PREPARATION OF ABSTRACTS**

1. Scientific works that have not been published before are accepted for publication.
2. Materials must be submitted in Ukrainian (for citizens of Ukraine) and English (for foreign participants).
3. Abstracts are sent to the e-mail. Name the files by example: Markiv\_Application; Markiv\_Thesis; Markiv\_receipt.
4. Materials must be prepared using the MS Word editor. Sheet format – A4. Margins - 2 cm on all sides. Font - Times New Roman, size – 12, line spacing – 1.0. Paragraph indent – 1 cm. Abstracts should not be numbered.
5. The volume of abstracts is up to 2 pages.
6. The general scheme of construction of theses:
  - name and surname of the author (bold), place of work (study), position – in the upper right corner.
  - below - in one space - the title of the report – in bold capital letters in the center of the page.
  - below - in one interval – the text of the report (abstracts).
7. At the end of the text the list of references is given (bold and centered). References in the text to the source and the pages in it are given in square brackets. The list of references is given at the end of the text by a bibliographic list of sources in the original language. Literature is made according to the interstate standard DSTU 8302: 2015 “Information and documentation. Bibliographic link. General requirements and rules of assembly”.
8. The use of illustrative materials should be minimal.
9. The orientation of tables and figures should be only bookish.
10. Editorial changes may be made to the text of abstracts without the consent of the author.
11. Works that do not meet the requirements or are not submitted in due time are not considered.
